Mayor Trantalis gave a history of events that led to the closure of the park. There was a lease between City of Fort Lauderdale and Broward health for \$1 per year that expired. Broward Health has asked for land to build a medical facility in exchange for the land that was "leased" to The City for the creation of Dottie Mancini Park. A deal fell apart that was made to satisfy this request. In the absence of another option, Broward Health locked the park citing a lack of agreement to allow the park to be open.

The City and Broward Health are exploring other options such as leasing the Park land to the City at fair market value and/or another land option.

We tried to get an exact date for the park to reopen and all parties stated that this is an important priority and it will happen soon. When pressed on what does soon mean, they were not willing to commit.



We expressed our extreme disappointment with our elected officials and Broward Health for holding our Imperial Point residents and families hostage while negotiations are ongoing for something that should have been solved before the lease expired.

Many members and resident spoke about the park and other City / County issues such as Short Term Rentals – The City's has no authority other than code/noise violations. We need to take this issue to our State officials, Chip LaMarca and higher.

Broward Health lack of response to resident inquiries – Stacy Angier asked for details to resolve. Fort Lauderdale Executive Airport (FXE) noise complaints – We will request FXE and FAA at a meeting dedicated to FXE Airport. Date and details to follow

Condition of roads, depressed areas in multiple locations. City Manager Chavarria requested code to be notified and that he would follow-up.

While we may have some optimism that the park will reopen, I think that it is in our best interests to continue to get residents and locals to sign the petition and continue our pressure on all parties involved. Community solidarity and action are key. Imperial Point is a very large voting block of the city and County. Let's make our voices heard! Additionally, involvement of local media to help our cause will be pursued.
