## Notice: Upcoming Inspections

### WATER SERVICE LINE MATERIAL INVENTORY

The City of Fort Lauderdale is conducting a Water Service Line Material Inventory in response to new regulations from the U.S. Environmental Protection Agency (EPA). This project aims to identify the materials used in water service lines to determine if they are made of lead.

Water service lines, which are the pipes connecting homes, businesses and other private properties to the City's water distribution system, play a crucial role in delivering safe drinking water. These pipes are usually buried in the yard or in front of a structure and are located between the water main and building. The portion of the service line between the water main and meter box is part of the public water system and is maintained by the City of Fort Lauderdale, while the remainder of the service line between the meter box and the building is privately owned.

Inspections will take place daily between 6 a.m. and 7 p.m. starting Saturday, August 3 and continuing throughout the month of August 2024 within the following neighborhoods:

- Limited lane closures are expected as crews will be working primarily within the shoulder of neighborhood streets.
- Access to driveways will be maintained.
- Please follow posted signs and drive with caution in the area.
